

**RESOLUTION 0505**

**WHEREAS, Caribou County Road and Bridge used Caribou County owned equipment to do ground work for the new Caribou County Jail during the fiscal year 2005, and the Caribou County Sheriff's budget resides within Current Expense: Caribou County Current Expense paid Caribou County Road and Bridge \$36,525.00 for work done for Caribou County;**

**WHEREAS, Caribou County Road and Bridge used Caribou County owned equipment to haul dirt for Caribou County Landfill during the fiscal year 2005, and the Caribou County Landfill budget resides in Solid Waste. Caribou County Solid Waste paid Caribou County Road and Bridge \$107,840.00 for work done for Caribou County;**

**WHEREAS, a revenue budgeting error was made to County Fair in the budget year of 2004-2005 causing County Fair to have no Tax Levy for that year, \$34,000.00 was transferred from PILT to County Fair;**

**WHEREAS, Public Safety Trust and Treasurers Trust have excessive funds, \$36,525.00 in Public Safety Trust and \$48,449.00 in Treasurers Trust, these amounts are to be transferred to Current Expense;**

**WHEREAS, money was received from various Counties and the State of Idaho for holding their prisoners in the Caribou County Jail during the fiscal year of 2005 and the Caribou County Jail incurred expenses during that same period in the amount of \$3,566.44;**

**WHEREAS, Road and Bridge Trust is to be closed and the remaining balance of \$13,214.71 is to be transferred to Road and Bridge; and**

**WHEREAS, a public meeting was duly advertised and held on September 26, 2005 to allow any persons an opportunity to object and there being none;**

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF CARIBOU COUNTY COMMISSIONERS, AS FOLLOWS:**

**That the fiscal year 2005 budget be opened and Caribou County Current Expense transfer \$36,525.00 to Caribou County Road and Bridge, Caribou County Solid Waste transfer \$107,840.00 to Caribou County Road and Bridge, PILT transfer \$34,000.00 to County Fair, Public Safety Trust transfer \$36,525.00 to Current Expense, Treasurers Trust transfer 48,449.00 to Current Expense, and \$3,566.44 be included in the Jail 2005 budget, Road and Bridge Trust closed and transfer \$13,214.71 to Road and Bridge.**
