R E S O L U T I O N

WHEREAS, the Caribou County Board of Commissioners deem it necessary to protect the health, comfort, and environment and the right of nonsmokers--both County employees and the general public to breathe clean air; and

WHEREAS, the Commissioners have a public duty to make reasonable efforts to prevent smoking in public places by posting appropriate no smoking signs; and, to enforce the provisions of Idaho Code 39-5501 through 39-5509;

NOW, THEREFORE, BE IT RESOLVED, that a motion was made by Commissioner Bruce M. Dredge, seconded by Commissioner Carol Davids-Moore, that any lighted cigar, cigarette, or pipe, is prohibited in any building or vehicle owned, controlled, or leased by Caribou County. Any office or room in any such building if frequented by any public employee or any member of the general public, is deemed a public place in which smoking is prohibited; and,

FURTHER BE IT RESOLVED, no smoking signs shall be posted in each County building by the Building and Grounds as the Commissioners have determined that there is no area in any Caribou County building to be designated a smoking area, with the exception of the break room in Caribou County Courthouse.


FURTHER, this Resolution shall be effective April 1, 1998.

RESOLUTION

WHEREAS, the Caribou County Board of Commissioners deem it necessary to protect the health, comfort, and environment and the right of nonsmokers—both County employees and the general public—to breath clean air; and

WHEREAS, the Commissioners have a public duty to make reasonable efforts to prevent smoking in public places by posting appropriate NO SMOKING SIGNS; and, to enforce the provisions of Idaho Code 39-5501 through 39-5509;

NOW, THEREFORE, BE IT RESOLVED, that Resolution dated March 23, 1998, is hereby amended to make no exception to the policy that smoking is prohibited in any building or vehicle owned, controlled, or leased by Caribou County.

FURTHER BE IT RESOLVED, that NO SMOKING signs shall be posted in all county buildings.

FURTHER, this Resolution shall be effective October 10, 2000.
